7. Development of Vocational Education Program on the basis of structure, modules and framework document

The framework document provides general and sectoral modules of 180 credits. The number of credits in general modules is 9 credits and 171 credits sectoral modules provide basic competencies, theoretical knowledge, practical training and learning outcomes in clinical environment.

Modules are classified as follows:

- General modules 9 credits
- Theoretical Teaching Basic Sciences / Sectoral Modules 24 credits
- Theoretical teaching Nursing / Sectoral modules 45 credits
- Theoretical Education Social Sciences / Sectoral Modules 6 credits
- Practical training 6 credits
- Clinical training 90 credits

Vocational education program developed on the basis of Vocational Education Program Framework and should provide both theoretical and practical knowledge. Also, should be included the clinical teaching component. The duration of the teaching-learning process should be at least three years, full time. The educational institution is responsible for the planning and coordination of theoretical and clinical studies. The clinical practice defined by the Framework Document (90 credits) is 50% of the full curriculum.

8. Learning Outcomes:

- 1. Assess the patient's health condition;
- 2. Implementation of a nursing care for a patient in the general ward
- 3. Implementation of a nursing care for surgical patient;
- 4. Implementation of a nursing care for emergency patient;
- 5. Implement of a nursing care for the patient in critical condition;
- 6. Implement if the nursing management of the perioperative patient;
- 7. Implementing of the nursing care for Ob/Gyn patient;
- 8. Implementation of pediatric nursing care;
- 9. Implement and provide home care services;
- 10. Implement and ensure the nursing care of the geriatric patient;
- 11. To Plan and evaluate the quality of ones own practice and care.

9. Confirmation of achievement of learning outcomes and grant credit

The learning outcome can be confirmed by the development and / or determining assessment. Developing assessment can be made using both the scores and the applicable principle.

The definitive assessment provides for the use of the system based on the principles of the deduction (based on the competence) and provides the following two types of assessment:

- A) Learning outcome is confirmed;
- B) Learning outcome can not be confirmed.

During vocational student's assessment, it is necessary for each learning outcome to be achieved by not less than 75% for each learning outcome.

If the outcome is not achieved, a vocational student has the right to request an additional assessment of the learning outcomes. Appraisal method / methods in the form of recommendations are given in modules.

10. Gaining qualifications

In order to gain Diploma, a professional student must collect the number of credits determined by this framework document and pass the qualification exam.
